

COVID-19 Home/School Agreement

Pupil

I will do my best to:

- ✓ Follow social distancing rules in class and in the playground.
- ✓ Stay in my group/bubble all day.
- ✓ Not mix with any children outside of my bubble whilst in school
- ✓ Tell an adult if I feel unwell.
- ✓ Not bring things into school from home, or take things home from school.
- ✓ Only use equipment provided by school.
- ✓ Only enter and exit the school building from the designated door or gate.
- ✓ Wash my hands with soap and water for 20 seconds when I arrive in school, before and after lunch, after I use the toilet and whenever I am told to.
- ✓ Follow good respiratory hygiene: coughing and sneezing into elbow or tissue (catch it-bin it-kill it).
- ✓ Behave well at all times to maintain the safety of myself and others.
- ✓ Follow these expectations and know that if I don't, I will be sent home and will not be able to come back into school until I can be safe.

I know and understand that:

- ✓ If my child, or anyone in my household, shows symptoms of COVID-19, I will not send them to school and we will self-isolate for 14 days as a family.
- ✓ If my child, or another child in the bubble, shows symptoms of COVID-19 at school, I will collect my child immediately.
- ✓ My actions will help to create a safer environment for my child and I will follow the school's instructions.
- ✓ I must adhere to school timings for dropping off/collecting my child.
- ✓ I must adhere to the 2 metre social distancing rules when travelling to school and when dropping-off/collecting.
- ✓ My child must not bring any items into school or take items home from school.
- ✓ I will remind my child about social distancing rules but accept that they may not always do this successfully.
- ✓ My child must follow good hygiene practices e.g. hand-washing
- ✓ I will not be allowed into the school without a pre-arranged appointment.
- ✓ If my child is deemed unsafe, they will be sent home and cannot return to school until they can be safe.

- ✓ Communicate between home and school through ParentMail, newsletters, email and the school website.
